

Privacy Policy

The following policy outlines how we collect and use the data that we collect from our websites, including the use of cookies.

Our Commitment to You

ION SENSE is committed to protecting your privacy and guarantee to treat any data we collect from you securely, fairly and lawfully. This privacy policy details the steps we take to protect your personal information when you visit our website, or submit a form on our website regarding one of our products or regarding our services.

Personal information refers to data that identifies an individual, such as name, postal address, email address or phone number. Newsletter choices, product purchases, instrument registrations and consumer product preferences are also associated with personal information.

By using our website or providing us with your information when you contact us, you are consenting to the information collection and use practices described in this privacy policy.

Collection of information

You are able to visit our website without revealing who you are or any information about yourself. If however, you fill in a form on our website we will receive and use the information that we collect in the ways outlined below.

We may collect the following information:

- Other information relevant to customer surveys and/or offers

What we do with the information we gather

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

• We may use the information to improve our products and services.

- We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided. We will always give you the option to unsubscribe to our emails at any time.
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone or mail. We may use the information to customise the website according to your interests.
- On submitting a job application or enquiry you may provide us with information, such as application form/CV/covering letter, including your name, title, contact details, photograph, employment history, experience, skills, qualifications/training (including educational, vocational, driving licences where appropriate), referees' names and contact details, etc.. If your application is unsuccessful, we will keep your personal data for up to 6 months from the date we notify you of our decision. (Note, we may keep your personal data for longer than 6 months if you have asked us to consider you for future vacancies). Please see our Job Applicants Privacy Notice for more details.

Cookies

Our policy for protecting your online privacy

This website uses Google Analytics to help analyse how users use the site. The tool uses "cookies", which are text files placed on your computer, to collect standard Internet log information and visitor behaviour information in an anonymous form. The information generated by cookie about your use of the website (including your IP address) is transmitted to Google. This information is then used to evaluate visitors' use of the website and to compile statistical reports on website activity for ION SENSE.

We will never use the statistical analytics tool to track or to collect any Personally Identifiable Information of visitors to our site. Google will not associate your IP address with any other data held by Google. Neither we nor Google will link, or seek to link, an IP address with the identity of our computer user. We will not associate any data gathered from this site with any Personally Identifiable Information from any source, unless you explicitly submit that information via a fill-in form on our website.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.



You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may however, prevent you from taking full advantage of the website.

The Interactive Advertising Bureau (IAB) is an industry body that develops standards and guidelines to support online business processes. It has produced a series of web pages that explain how cookies work and how they can be managed.

Disclosure of information

Disclosure of your personal information

Any personal information that we collect about you through our websites or that you provide to us when you contact us will not be shared outside of ION SENSE without your permission, except as described below.

Disclosure to service providers

ION SENSE outsources a number of services which allows services to be provided on our behalf, such as website hosting, conducting surveys, performing analyses to improve the quality of our business, our products or services. The companies we deal with receive only the data that is needed containing your personal information to deliver those services effectively and are prohibited from using personal information for any other purpose.

Disclosure of information to our ION SENSE Global Offices

This ensures that you receive timely and localized service and support.
